## Applications for Visa for Employment as Cook in Germany

Dear Applicant,

thank you very much for your interest in an employment as cook in the Federal Republic of Germany.

All foreign nationals, who wish to work in the Federal Republic of Germany, require a visa prior to their departure. Applicants residing in Andhra Pradesh, Tamil Nadu or Pondicherry have to submit their respective visa applications to the Consulate General of the Federal Republic of Germany in Chennai. Please note that the place of issue of your passport is of no relevance in this regard.

In order to start the application process, please contact any of the German Application Centers in Chennai, Puducherry and Hyderabad managed by "VFS Global Services Pvt. Ltd". Please note that you are required to present a complete set of application documents there for a preliminary check. After the document check an appointment for the mandatory visa interview in the German Consulate General in Chennai will be scheduled. Applications may not be submitted by courier, regular post, fax or e-mail. Please refer to the homepage of the German Consulate General at [www.india.diplo.de](http://www.india.diplo.de) for further information. For its services "VFS Global Services Pvt. Ltd" is charging a service fee of 607 Rupees (incl. taxes) per application. This fee is not related in any way to the visa fee itself.

Please note that all applicants, who wish to work as cook in Germany, have to pass a **cooking test** before applying for their visa. The examination certificate has to be presented along with all other required application documents. It may not be submitted at a later time. The International Institute of Culinary Arts (Daryacha, 39 Hauz Khas Village, New Delhi 110 016, Tel.: (011) 2685 0817 or (0)9811999618, Fax: (011) 2646 1093, e-mail: [culinaryarts@chefiica.com](mailto:culinaryarts@chefiica.com).) is the only Hotel Management School in India recognized by German authorities to conduct the cooking test. The charges for conducting the cooking test including assistance with the application procedure will amount to 300,- Euro (to be paid in Rupees). Please note that the German Consulate General is not connected with the Institute and has no influence on the fees charged.

After receipt of your visa application the German Consulate General will decide if your application meets the basic criteria for an Employment Visa. In this case the German Consulate General will return your passport with a visa fee receipt to you via the Application Centers and the mandatory verification process of your documents will be started. Upon a positive result of the document verification your application will be forwarded to the competent **Immigration Office in Germany** for approval. If the basic criteria are not met, you will receive a reject letter.

Please note that in each case, all documents of Indian origin have to be verified. The **verification process** will be initiated automatically by the German Consulate and might take approximately 8-12 weeks. The verification fee is 15.000,- Rs and has to be paid in Rupees by **Demand Draft** in the name of the "Shankar R., Chennai" on the day of application. The Demand Draft must be payable in Chennai and may not be older than two months. Only Demand Drafts from the Indian Bank, Canara Bank, RBS or Deutsche Bank will be accepted. Demand Drafts with incorrect amounts will not be accepted. Fees cannot be paid in cash. Please note that the verification fee is **not refundable**, even when the visa is refused.

The German Immigration Offices will require **another 4-5 months for processing your visa application (in addition to the processing time for the verification process)**. Please note that the German Consulate General has no influence on the actual processing time. After the German Immigration Office has notified the German Consulate General in Chennai of its decision, you will be contacted in writing.

Upon receipt of our approval letter, you can make travel arrangements. When ready, please submit your passport, your travel itinerary (ticket is not required) and a copy of our approval letter via the Application Centers for visa stamping. Please note the **visa approval is valid for 20 days only**. You, therefore, should arrange to have your visa stamped within this period of time. If you fail to meet this deadline, your visa will be rejected automatically and you will have to start the visa process all over.

The German Consulate General will issue a visa valid for three months only. This visa will enable you to enter the Federal Republic of Germany legally in order to take up residence there. It also permits to travel within the Schengen area. Nevertheless, it is mandatory to register immediately upon arrival with the local Immigration Office which will grant the **final residence permit**.

Once again, we would like to point out that the **visa process** including the document verification might take **6-8 months**. Applications should, therefore, be submitted at least 8 months prior to the intended departure for Germany. Simultaneous applications for visiting visa in order to “bridge” the processing time of the employment visa cannot be entertained. Visa for tourist or visiting purposes cannot be converted into residence permits after arrival in Germany.

**Any enquiries in writing or by telephone for the status of an application within a period of 12 weeks from date of application cannot be answered.**

The **Visa Fee** for an Employment Visa is € 60,-. The visa fee has to be paid in Rupees by **Demand Draft** in the name of the “Consulate General of the Federal Republic of Germany, Chennai” on the day of application. The Demand Draft must be payable in Chennai and may not be older than two months. Only Demand Drafts from the Indian Bank, Canara Bank, RBS or Deutsche Bank will be accepted. Demand Drafts with incorrect amounts will not be accepted. Fees cannot be paid in cash. Please refer to the homepage of the German Consulate General at [www.chennai.diplo.de](http://www.chennai.diplo.de) in order to find out the current amount of the visa fee in Rupees. Please note that the visa fee is **not refundable**, even when the visa is refused.

In order to ensure that your application can be processed without delay, please submit the following mandatory documents:

- valid **Passport** (issued within the last 10 years) with at least 12 months validity
- **3 Passport Pictures** according to biometric specifications, 1 attached to each application form, 1 loose (For further details regarding biometric specifications of photos please refer to the German Consulate General’s homepage at [www.chennai.diplo.de](http://www.chennai.diplo.de))
- **Demand Draft** for Visa Fee
- **Demand Draft** for Document Verification Fee (20.000 Rs)

In addition you are requested to provide **two sets of application documents** containing the following documents:

- **Application Form** (Please ensure that you signed both forms and indicated your complete future address incl. pin code in question 15. Besides, please add your complete Indian address incl. pin code and Tel./Fax/e-mail under your signature.)
- **Declaration on True and Complete Information**, signed and dated
- your **Cover Letter** explaining the reason for your visa application (Original)
- **Letter from your future German Employer** in German language confirming employment (Original)
- your **Work Contract with a German Employer** giving details regarding your future salary and social insurance payments (Original and A4 sized copy)
- **Proof of Qualification from the International Institute of Culinary Arts, New Delhi** (cooking test, Original and A4 sized copy)
- **ZAV Application Form** (will be filled out by the International Institute of Culinary Arts, New Delhi, Original and A4 sized copy)
- **Experience Certificates** of at least 6 years of work experience as cook specialized in Indian food (Original and A4 sized copy)
- **Curriculum Vitae** (bio data in tabular form, typed)
- your **Birth Certificate** (Original and A4 sized copy)
- your **School Leaving Certificate** (Original and A4 sized copy)
- A4 sized copy of **your passport**

All required forms / declarations as well as this information sheet may be downloaded from the visa page of the German Consulate General’s homepage at [www.india.diplo.de](http://www.india.diplo.de).

**Please note that the German Consulate General reserves the right to ask for additional documents in single cases. Besides, the submission of the above mentioned documents does not guarantee the issue of a visa. Submission of an incomplete set of documentation or refusal to attend the mandatory visa interview will lead to a reject of your visa application. Even though a visa might have been granted, Border Control Authorities at the port of entry reserve**
